ARTICLES OF INCORPORATION ADDITIONAL PROVISIONS

- **I. PURPOSE.** The corporation shall exist for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, and more specifically described as follows:
- (a) Assist low-income, promising high school students (principally in rural Colorado) to apply to college by assisting those students with all aspects of the application process, including internship opportunities, college selection, resume writing, essay editing, FAFSA guidance, interview tips, and research into scholarship opportunities for each individual student.
- (b) Serves low-income college students and college graduates by assisting them with their graduate or professional school applications, including fellowship opportunities, university selection, resume writing, essay editing, interview tips, and research into scholarship opportunities for each individual student.
- (d) To exercise any and all powers conferred by Colorado Revised Statutes ("C.R.S.") §7-123-102 General Powers and other powers as conferred by C.R.S. §7-123-101 *et. seq.* and the Colorado Revised Nonprofit Corporation Act, as may be amended from time to time, consistent with the purposes stated herein.
- II. PROHIBITED ACTIVITIES. No substantial part of the activities of the corporation shall consist of carrying on propaganda or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- III. RESTRICTIONS ON DISTRIBUTION OF CORPORATE EARNINGS. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered.
- **IV. DISTRIBUTION UPON DISSOLUTION.** Upon dissolution, the assets of the corporation will be distributed to a 501(c)(3) non-profit organization with a similar mission.
